1. Purchase

1.1 Le Domaine de L'Orangerie offers gift vouchers for sale ("Gift Certificate"). Gift Certificates can only be redeemed at the hotel for which they were purchased. Gift Certificates are released by the hotel only. Gift Certificates are only valid for goods and services operated by the hotel, as per the above list.

1.2 No contract for the sale of any Gift Voucher will subsist between you and Le Domaine de L'Orangerie, unless and until Le Domaine de L'Orangerie accepts your order by way of an email or fax detailing that payment has been received in full, the content of the Gift Voucher purchased and confirming your details.

1.3 You must check that the details of the confirmation are correct as soon as possible and you should print out and keep a copy of it. Gift Certificates can be used once only.

1.4 Payment shall be taken on our behalf by credit card (Mastercard, Visa, American Express) through a signed authorization to debit a card form, at least 2 working days prior to the arrival of the client, for operations and preparation purposes. 1.5 You undertake that all details you provide to Le Domaine de L'Orangerie for the purpose of ordering Gift Voucher are correct, that the credit or debit card you are using is your own and that there are sufficient funds to cover the cost of the Gift Voucher ordered.
